5. EoP PoW's –v– Nobel Committee & Peace Laureates et al; or
6. EoP PoW & GMACCC –v– Cop21 Min of Environment Signatories; based upon EoP PoW's –v– Nobel Committee & Peace Laureates et al 'crimes of aggression' and 'EoP Cop21 Simple Root Cause Problem Solving Recommendation to Political Parties'.

I am only a paralegal who has been acting as a pro-bono pro se applicant and pro bono clerk for other applicants who have been acting as plausible deniable pro-bono applicants along with another set of plausible deniable observers; and the aforementioned summary is simply my suggestions not only to any formal assistance of counsel or lead counsel attorney; but also to applicants and observers.

I shall deal with them in a bit more detail; in what I consider logical order.

Legally confirm EoP Applicants as ICC Private Prosecution Applicants.

The pro bono applicants are: Nanette Derenzi: former US Navy JAG; Dennis McGinn: Assistant Secretary of the Navy: Energy, Installations & Environment; Timothy McVeigh: OKC bomber currently employed at NSA; Erik Prince: Former Founder of Blackwater; Vladimir Putin: President of Russia; David Petraeus: Former CIA Director; Stan McChrystal: McChrystal Group; Ray O'Dierno: Former US Army Chief of Staff; John Mulholland: current CIA Pentagon liaison.

The pro bono observers have been: Jay Bybee: Judge at United States Court of Appeals for the Ninth Circuit; David Coombs: Bradley Manning attorney; Zbigniew Brzezinski: former advisor to President Carter; Generals: Dana Pittard; Herbert Raymond McMaster, George Flynn and James Mattis; John W. Whitehead: Constitutional Attorney; Donald Rumsfeld: Former Sec of

Defence; Supreme Court Justices via DoJ: SupremeCtBriefs; Holy See in London; Grand Lodge of TX: Grand Secretary; Arif Hasan Akhundzada: Pashtun Pakistan citizen.

Re: plausible deniable applicants and observers:

According to my observation two of the applicants could be considered plausible deniable committed to the implementation of an Ecology of Peace international law social contract. They are Timothy McVeigh and Vladimir Putin.

I imagine Timothy McVeigh shall remain plausible deniable until Pres Bush and/or Governor Gray Davis legally confirms his 11 June 2001 faked execution. Those negotiations can be found in: *Ecology of Peace culture correspondence regarding the Oklahoma City Bombing and the faked execution of Timothy James McVeigh [PDF]*. I imagine Vladimir Putin shall remain plausible deniable until (i) the issue of McVeigh's faked execution is resolved; and/or (ii) Israel ICC coercion issues are confirmed; although I could be wrong on both those counts; and President Putin may be willing to discard his plausible deniability based upon the same grounds as the plausible deniable working hypothesis enquiry applicants. One thing I have little doubt about is his level of EoP commitment.

The other applicants I would classify as closer to plausible deniable working hypothesis enquiry; some closer to committed and others closer to enquiry; where exactly on that scale they would fall; I don't know. I imagine they would tilt closer to committed with a qualified counsel on board; particularly one who could not only represent both military and peace principles; but also 'outside the mainstream normal box' legal principles; such as yourself.

Filing of: EoP PoW's -v- Nobel Committee & Peace Laureates et al or EoP PoW & GMACCC -v- Cop21 Min of Environment Signatories:

Summary: EoP PoW's -v- Nobel Committee & Peace Laureates et al

This is a private prosecution complaint to the International Criminal Court in terms of Rendulic Rule Military Necessity doctrine; CA, UK, US & RSA Common Law Private Prosecution doctrine; Rome Statute: Art.5, 6, 7, 8 & 15; ICC Code of Judicial Ethics: Art 4, 5(1), 7 & 11.

Purpose: Nuclear Freedom Mutual Coercion Military Necessity for the Implementation of an Ecology of Peace international law social contract

Charges: Crimes of Aggression Acts of War.

Accused Respondents:

Norwegian Nobel Committee; Nobel Peace Laureates; Bank of Intl Settlements; Inter-American Dev Bank; APRACA: Asia-Pacific Rural & Agriculture Credit Assoc; WFE: World Fed. of Exchanges; OICU-IOSCO: Intl Org of Securities Commissions; IAEA: Intl Atomic Energy Agency; NEI: Nuclear Energy Institute; WCA: World Coal Assoc.; UN General Assembly States & UNDP / UNFPA / UNOPS Executive Board Secretariat.

Accused Respondents have the option of (i) consenting to private prosecution proceedings; to willingly hold themselves accountable to take responsibility for their crimes of aggression acts of war overconsumption and/or procreation and voluntarily cooperate; or; (ii) refusing to consent and hence being coerced to cooperate; to nonviolently deindustrialize and reduce consumption

and procreation to ecological carrying capacity limits; through specific actions requested of them.

Ecology of Peace Decalogue Commandment definition for ‘crimes of aggression acts of war; is as follows: “Any individual who is found guilty of advocating on behalf of, legislating, enforcing, or obeying any – cultural, religious, common, statutory, constitutional, or international – ‘scarcity combatant’ social contract; which enables or advocates on behalf of human procreation, consumption or production of resources that transgress ecological carrying capacity limits, is guilty of the ‘crime of aggression act of war’.”

Carrying Capacity Sustainability: I=PAT Equation: For activities to be genuinely sustainable it must be possible for them to continue indefinitely. The impact of humanity on the environment and the demands that people place on the resources available on the planet can be summarised by what is known as the Ehrlich or IPAT equation, $I=PAT$. I = impact on the environment or demand for resources, P = population size, A = affluence and T = technology. The two most important conclusions deriving from this IPAT footprint relationship are that: (i) the Earth can support only a limited number of people, at a certain level of affluence, in a sustainable manner; and (ii) Population and Consumption must be reduced to below carrying capacity.

Carrying Capacity aka Biocapacity Limits: “The maximum number of individuals that can be supported sustainably by a given environment is known as its ‘carrying capacity’. Worldwide the total amount of biologically productive land and sea amounts to 12 billion global hectares (gha); or 1.8 gha each if divided by 6.7 billion each. Guerrylla Laws are drawn up in accordance with the proactive conservation policies of Bhutan, who set aside 40% of their biologically productive to be returned to its natural state, for other species and wildlife conservation purposes; then that means that the total amount of biologically productive carrying capacity land available to humans is 60% of 12 billion; which amounts to 7.2 billion gha total; or 60% of 1.8 gha, which is 1 gha each. Population factor is relevant, because the more humans there are, the less biologically productive land there is for everyone else.

Consumption Violation Sentences: Individuals found guilty of violating consumption social contract limits; would be required to (A) either relinquish their excess consumed products; or if already spent pay an appropriate financial fine; to a conservation trust fund or similar; and (B) sign a legal agreement – similar to the MILINT Earth Day Ecology of Peace Oath [PDF] – with law enforcement authorities to commit to consuming below carrying capacity limits, and failing to honourably do so authorizing a Judge to authorize law enforcement officials, to remove their dishonourable genes from the national genepool.

Procreation Violation Sentences: Individuals found guilty of violating procreation social contract limits; would be required (A) to (i) relinquish said child for adoption (if wanted to be adopted by a family) and agree to be permanently sterilized; and (ii) sign a legal agreement – similar to aforementioned MILINT Earth Day Ecology of Peace Oath – with law enforcement authorities to commit to consuming below carrying capacity limits, and failing to honourably do so authorizing a Judge to authorize law enforcement officials to remove their dishonourable genes from the national genepool; (B) if no adoptive family is found; both parents and children are to be given their choice as to how they prefer to be humanely executed.

Crimes of Aggression Acts of War Sentencing: Military and Intelligence agency officials shall deliver the humane and orderly ‘genepool cleansing’ termination by assassination sentencing of all convicted accused; whose scarcity combatant bodies shall not be buried, but dumped into former coal, granary or other related silo’s to be organically converted into compost.

Summary: EoP PoW's & GMACCC –v– Cop 21 Min of Environment Signatories

This could either supplement *Summary: EoP PoW's –v– Nobel Committee & Peace Laureates et al;* or perhaps even replace it; as a simpler more effective option; based upon the same ‘crimes of aggression acts of war’ charges and definition.

In this case however the respondent parties would be required to consent to the following legally binding suggestion; as per the 10 December 2015: EoP Cop21 Simple Root Cause Problem Solving Recommendation [[PDF](#)]; to eliminate the manmade causes of global warming.

Negotiators from over 190 countries – representing citizens from many different races, classes, cultures, religions – have come together to negotiate a ‘climate change agreement’; to stabilize atmospheric concentrations of greenhouse gases (GHGs) to avoid “dangerous anthropogenic interference with the climate system”; with the aim of keeping global warming below 2°C.

Simplify Suggestion:

“If you can't explain it simply, you don't understand it well enough.” - Albert Einstein

1. Climate change – like food shortages, food inflation, cost of living increases, urban sprawl, traffic jams, toxic waste, pollution, peak oil, peak water, peak food, peak population, species extinction, loss of biodiversity, peak resources – is a direct and indirect consequence of overpopulation and overconsumption.
2. Overconsumption and overpopulation are a direct consequence of humans procreating and consuming above ecological carrying capacity limits.
3. Humans procreate and consume above ecological carrying capacity limits because the current international law social contract; provides the worlds nations citizens with the ‘right to breed and consume with total disregard for ecological carrying capacity limits’.
4. Humans will stop procreating and consuming above ecological carrying capacity limits when legislators amend the international law social contract; to require all the worlds citizens to procreate and consume below ecological carrying capacity limits.

EoP Cop21 Simple Root Cause Problem Solving Recommendation:

Cop 21 negotiators agree to support international law legislation requiring all the worlds nations political parties to agree to implement national legislation by 11 September 2016; that requires all their citizens to procreate and consume below ecological carrying capacity limits. Any political party which refuses to cooperate; is to lose their political party license. Any nation that refuses to remove the violating political party’s license may be legally charged in an international court; by any individual in that nation or another nation with the intention to bribe their citizens to overbreed or overconsume; which shall be considered

crimes of aggression acts of war; punishable by the death penalty for every single member of that political party.

Once implemented all political parties will be on an even playing field and will no longer be able to bribe their citizens with individual or corporate welfare to vote for their political party. Politicians shall have to find their [Thomas Sankara](#) backbones; to cooperate with their citizens to teach them how to become cooperating self-reliant sustainable nations.

PM Netanyahu & Mossad consent as EoP Axis Coercion:

Basis for recommendation of EoP Axis include among others; which has been shared with EoP Axis authorities; include among others: Real News: [Paul Jay's Reality Asserts Itself: Who Makes US Foreign Policy interview of Lawrence Wilkerson](#); particularly the [predatory capitalism](#) part; which deals with the necessity of the great powers cooperating to implement a new economic order; to address the massive impending planetary social conflict problems resulting from climate change, peak food, peak water, peak oil, etc.

EoP Axis Officials confirm EoP Axis Military Necessity Evacuation Orders to NSA, FSB, NATO & People's Liberation Army of China; in the event coercion of any ICC respondents is considered necessary.

The EoP Axis Lotto Coercion option, basically recognizes that as in Star Trek; we are all to blame; some more than others; but very few can consider themselves ecologically innocent in terms of having procreated and/or consumed below ecological carrying capacity limits. Recognizing this reality; we must implement a coercion option that targets the individuals (a) with the largest procreation and/or consumption footprint: i.e. breeding / consumption war extremists; (b) who are members of professions who are considered to be 'social conflict' problem solving leaders; who have clearly failed to educate their nation's citizens about Ecology of Peace reality facts.

EoP Axis Military Necessity Evacuation Lotto pool consists of nation states starting with 25 nations with highest scarcity combatant footprints. Each lotto draw will select two nation states. The two lotto Nation states shall have half of selected Scarcity Combatants – Lawyers, Mental Health, Organized Religion, Charity Non-profits, Media and Breeding/Capital War extremists – evacuated; excluding scarcity combatants who have signed EoP Axis Oaths. Evacuated means humanely eliminated by means of psychotronic technology that terminates the functioning of their bodily organs; their bodies are to be disposed of in silo's for composting.

Cities: → City administrators must reduce their city populations to a maximum of 25,500 residents. Their cities must be separated from the next city by a green corridor of minimum 5 miles; between itself and neighbouring 'city' to be considered a second 'separate city' for the purpose of 'resident counting'; and the green corridor should be 25 miles from any third city.

Scarcity Combatants: → Law: Judges, Prosecutors & Lawyers; Mental Health: Psychologists & Psychiatrists; Media: Print, TV or Radio: Editors, Producers & Journalists; Religious & Non Profit: Officials and Employees of any religious worship or charity organization with State non-profit status.

Breeding / consumption war extremists: → Any adult individual over the age of 18 who qualifies as an extremist Scarcity Combatant: i.e. Breeding: any individual who has co-procreated more than 3 children who survived beyond the age of 5; Capital/Consumption: any individual whose capital assets amount to more than US \$ 2.55 million.

The EoP Military Necessity Mutual Coercion ICC Option Lotto Evacuation shall continue until (a) all nations national leaders have provided 'EoP Axis of Mutual Coercion' authorities with their Nations verified EoP Axis oath commitment of unconditional cooperation; and (b) all nations chief prosecutorial authority: attorney general / public prosecutors have filed their written consent with the International Criminal Court registrar for private prosecution proceedings of [EoP PoW's -v- Nobel Committee & Peace Laureates et al](#); or (c) their written legal objections.

If you decide to agree; my suggestion would be that you be lead counsel. I have also been contacting other attorneys; some of whom may be willing to provide their legal skills assistance; particularly with a lead counsel such as yourself who could not only represent both military and peace principles and experience; but also 'outside the mainstream normal box' legal thinking and advocacy.

EoP ICC Private Pros Re: WiP Kampala 'crimes of aggression' definition

I have not received a response from **Global Institute for the Prevention of Aggression: Don Ferencz** to my 25 December 2015 correspondence; Subject: *GIPA: Donald Ferencz: Re: EoP PoW et al -v- Nobel, GIPA et al & GIPA WiP 'crimes of aggression' definition [PDF]*; again informing him that the EoP Applicants dispute the Kampala definition of 'crimes of aggression acts of war'; as an ecologically and egologically illiterate Masonic War is Peace 'crimes of aggression' definition that ignores the root Masonic War is Peace 'right to breed / consume with total disregard for ecological carrying capacity limits' statutes of the Masonic War is Peace international law social contract; that is the foundation of resource depletion and local, national and international resource wars some of which result in genocides and holocausts.

EoP Simplify Suggestion:

5. Nation states standing army or dissident guerrilla army ‘terrorism’ resource war military aggression – like climate change, food shortages, food inflation, cost of living increases, urban sprawl, traffic jams, toxic waste, pollution, peak oil, peak water, peak food, peak population, species extinction, loss of biodiversity, peak resources – are a direct and indirect consequence of overpopulation and overconsumption.
6. Overconsumption and overpopulation are a direct consequence of humans procreating and consuming above ecological carrying capacity limits.
7. Humans procreate and consume above ecological carrying capacity limits because the current international law social contract; provides the worlds nation states constitutions provide nation state citizens with the implied ‘right to breed and consume with total disregard for ecological carrying capacity limits’.
8. Humans will stop procreating and consuming above ecological carrying capacity limits when legislators amend the current international law and national constitutional social contract statutes that enable procreation and consumption above ecological carrying capacity limits; to specifically require all the worlds/their nations citizens to procreate and consume below ecological carrying capacity limits.

If or when such EoP international law legislation existed: Any political party that attempted to bribe its nations citizens to vote for it; or to fund it; in exchange for offerings of ‘right to breed’ or ‘right to produce/consume’ above ecological carrying capacity limits; could be charged with crimes of aggression acts of war in the nations courts; and if found guilty lose their political party licenses. Current International Law Right to Breed & Consume:

There are many examples of current international law statutes that directly and indirectly provide citizens with the right to breed and/or consume above ecological carrying capacity limits; and lawyers, prosecutors and Judges who apply them, all while pretending their courts are concerned with ‘truth’ and ‘evidence’; pretending they have fuck all clue why and how those

statutes result in food shortages & inflation, cost of living increases, urban sprawl, traffic jams, toxic waste, pollution, peak oil, peak water, peak food, peak population, species extinction, loss of biodiversity, peak resources and climate change; inter-racial, religious and cultural social conflict; psycho-social conflict; not to mention overpopulation and consumption resource depletion and scarcity induced [resource wars](#); which sometimes manifest as genocide and holocausts.

Put simply: unlike [Arthur Edens](#) and [Michael Clayton](#) – they are in total denial that they are Sheva the legal cryptic gods of death.

See for example: Article 55 of [Charter of the United Nations](#): “With a view to the creation of conditions of stability and well-being which are necessary for peaceful and friendly relations among nations based on respect for the principle of equal rights and self-determination of peoples, the United Nations shall promote: (a) higher standards of living, full employment, and conditions of economic and social progress and development; (b) solutions of international economic, social, health, and related problems; and international cultural and educational co-operation; and (c) universal respect for, and observance of, human rights and fundamental freedoms for all without distinction as to race, sex, language, or religion.”

What would be the current world stability and peaceful relations reality be if it had; or once it does state:

“With a view to the creation of conditions of stability and well-being which are necessary for peaceful and friendly relations among nations based on respect for the principle of equal rights and self-determination of peoples, the United Nations shall (a) require all nations to (i) restrict their citizens procreation and consumption to no higher than 50% of national ecological carrying capacity limits; 10% reserved for emergencies; and 40% reserved for wild species national park habitats’ and (ii) educate their citizens about the simple buck stops here honesty communication practices principles to engage in fully informed consenting agreements to nonviolently resolve cultural misunderstandings and/or disputes; (iii) provide national enforcement mechanisms for citizens to hold each other and/or their nations elected officials accountable to ecological carrying capacity and fully informed consenting agreement principles; (b) provide international enforcement mechanisms to hold nations accountable to ecological carrying capacity and fully informed consenting agreement principles with their citizens and/or other nations; providing for a world where all of its nations and citizens are required to breed and consume below ecological carrying capacity limits; and engage in fully informed consenting – sub-culturally lawful – agreements with each other.”

Consequently if and/or where any two or more citizens are abiding by national and international procreation and/or consumption ecological carrying capacity limits regulations; if or where they are engaged in fully informed consenting agreement conduct in a private or culturally private venue – such as for example [Armin Meiwes](#) and [Bernd Brandes](#) fully informed consenting cannibalism – their fully informed consenting agreement actions with each other in their private venue shall be sub-culturally lawful; irrespective of how insulting or offensive or ‘culturally unlawful’ such behaviour and actions are to state officials or citizens who are not members of that particular culture; and were not invited to participate in those ‘sub-culturally lawful’ activities.

Why and When to Ratify the Kampala Amendments:

GIPA: [Why and When to Ratify the Kampala Amendments](#) states among others:

“Promote peace and the rule of law at the international level, by helping to establish a system of international criminal accountability aimed at enforcing the most fundamental rule governing the peaceful coexistence of nations: the prohibition of the illegal use of force. Activating the Court’s jurisdiction over the crime of aggression will help prevent illegal uses of force, as leaders will have to take the Court’s jurisdiction into account when taking relevant decisions. Ratifying States will do their part to help fulfil the promise of Nuremberg that never again would those who dare to commit the crime of aggression do so with impunity.”

How does the WiP Kampala ‘crime of aggression’ definition promote peace; if it totally and entirely ignores the root – Masonic War is Peace ‘right to breed/consume with total disregard for ecological carrying capacity limits’ – cause of resource depletion and resource war political, religious, cultural, economic, legal and military resource war aggression?

“Protect human rights and prevent suffering, since acts of aggression typically bring with them countless violations of human rights and international humanitarian law, affecting in particular the most vulnerable individuals during conflict, such as women and children. The effective criminalization of aggression will contribute to the prevention of such acts by targeting the very behaviour that stands at the beginning of the causal chain – the behaviour of the decision-makers who unleash the illegal use of force.”

How does the WiP Kampala ‘crime of aggression’ definition protect human rights and prevent suffering from resource war aggression; if it totally and entirely ignores the root – Masonic War is Peace ‘right to breed/consume with total disregard for ecological carrying capacity limits’ – cause of resource depletion and resource war political, religious, cultural, economic, legal and military resource war aggression?

“Close a loophole in the Rome Statute, since currently the Rome Statute does not protect the life of combatants who are unlawfully sent to war, nor the right to life of the soldiers of the attacked State; they are deemed to be legitimate targets who may be killed at will, provided the relevant rules pertaining to the conduct of hostilities are followed. This is a serious loophole in international law that needs to be closed.”

“Safeguard their legitimate security interests in conformity with the UN Charter. The definition of the crime of aggression in Article 8 bis leaves no doubt that the use of force in proper self-defence, as well as the use of force authorized by the Security Council cannot qualify as an act of aggression. The definition covers only the most serious forms of the illegal use of force, namely those that manifestly violate the UN Charter by their “character, gravity

and scale". States Parties to the Rome Statute took great care to ensure that the amendments would not adversely affect the legitimate security interests of States."

"When to ratify the amendments? The answer in short: as soon as possible. There is no reason to wait. At the 2010 Review Conference, States Parties expressed their resolve to "activate the Court's jurisdiction over the crime of aggression as early as possible" (Resolution RC/Res.6). The earliest moment in time for such activation is "after 1 January 2017", when States Parties will have to take a one-time decision to allow the Court to exercise jurisdiction over the crime of aggression. This decision will however only take effect once the amendments have entered into force for 30 States Parties. Since the amendments only enter into force for any ratifying State one year after the deposit of the instrument of ratification, the threshold of 30 ratifications should ideally already be reached by 1 January 2016 (or practically speaking, by the end of 2015). Given how long the domestic process for ratification of international instruments can take in many countries, those wishing to support the activation of the Court's jurisdiction over the crime of aggression should start the process as soon as possible."

I don't pretend to be an expert on *the domestic process for ratification of international instruments can take in many countries*; and I have submitted my Ecology of Peace arguments clarifying the ecological and egological illiteracy errors in the current Kampala crimes of aggression acts of war definition.

Whether it is better to allow the *Court's jurisdiction over Kampala crime of aggression* to pass or to attempt to prevent it from passing; I imagine; would depend on how cooperative Kampala crimes of aggression parties are or shall be to amending Kampala crimes of aggression definition to the Ecology of Peace crimes of aggression definition.

Totalitarian Agriculture as the source of Taker resource scarcity social-conflict contract problems:

The problems with Taker social contract occurred with the invention of Totalitarian agriculture; which describes the behaviour of humans who violate their original indigenous tribal territory's by choosing to engage in surplus food production (economic growth); resulting in surplus human (population growth).

When any tribe of humans overbreed and/or overconsume the natural resources in their perceived tribal territory; they travel beyond their tribal territory to go and find resources they have over-consumed and degraded. When such a tribe enters another tribes territory, then conflict occurs (from economic, political to physical, an organized violence warfare). To limit inter-tribal territorial resource acquisition conflict, all tribes must agree to limit procreation and consumption to their tribal territory ecological carrying capacity limits.

Simplistically the history of war can be summed up as: Every single battle between two groups of racial, religious, ethnic, or ideological warriors, engaged in organized violence resource thieving or defence, since the advent of [totalitarian agriculture](#), was a result of one or both of those tribes having overbred and/or overconsumed, and engaging in resource thieving into another tribes territory.

Since the beginning of humans (whatever you believe that beginning to be) humans lived in nomadic hunter gatherer tribes, like the Bushmen, Aborigine's, etc. Male duties were to hunt and protect the tribe. Women's duties were to forage and nurture the young. Both men and women contributed to the tribe's economic resources and duties, hence power was shared reasonably equally. Tribes were concerned about not overbreeding; since such overbreeding resulted in the resources in a territory being depleted quicker, and less resources for the rest of the tribe; requiring them to move to new territories. After three million years of humans living like hunter gatherers, it is estimated that the human population at the beginning of the Neolithic period was around ten million.

Then things changed very quickly for the tribes who invented Totalitarian agriculture. Women invented agriculture, resulting from their close association and experimentation with seeds and plants, in their role as foragers. This change occurred because some tribes started practicing a particular form of 'surplus agriculture' (hereinafter referred to as 'totalitarian agriculture') where farmers grew large surpluses of stored food. The consolidation of agriculture results in the centralization of political power: cities & civilization. Before the discovery of oil and coal, the practice of totalitarian agriculture farming was far more labour intensive than hunting and subsistence farming; so men took over agriculture; and women were now relegated to being brood sows, to breed economic and cannon fodder: children to work in the fields or be soldiers. Surplus food meant that some members of the tribe could now work in other

specialized fields: soldiers, clerks, etc; and also that the tribes could grow their tribes population. World population doubled in three thousand years; and again in only two thousand years. It jumped from ten million to fifty million—probably eighty percent of them being practitioners of totalitarian agriculture. It was getting crowded.

Beginning of War is Peace War resulting from overbreeding and overconsuming: In all of three million years, humans had never been crowded anywhere. But now the people of practicing totalitarian agriculture were learning what it means to be crowded. Overworked, overgrazed land was becoming less and less productive. There were more people, and they were competing for dwindling resources; and people now began to organize their tribes into forms of standing armies to fight for land or resources. The tribes first war-making machinery: warlords—kings, princes, emperors and their nation states formed for the purpose of armed defense and aggression. “It’s during this period that we see the standing army forged as the monarch’s sword of power. Without a standing army, a king is just a windbag in fancy clothes. But with a standing army, a king can impose his will on his enemies and engrave his name in history—and absolutely the only names we have from this era are the names of conquering kings. No scientists, no philosophers, no historians, no prophets, just conquerors. For the first time in human history, the important people are the people with armies.”

Evolution of War is Peace War: Advancement and acquisition of Human and Military Technology and Capital vs Breeding of CannonFodder: In a battle between two armies with the same level of military skill and technology; generally the bigger army wins. Many of history’s military conquerors have relied on simply growing cannon fodder to slaughter on the battlefields to win their battles or wars. Some military conquerors focussed on improving their soldiers skills (psychological, physical, intellectual, spiritual, etc), technology (better armor, better swords, better chariots, better bows and arrows, better scaling machines, better rams, better artillery, better guns, better tanks, better planes, better bombs, better rockets, better nerve gas, better germs, better chemicals); and legal moral supremacist ‘innocence for sale’ indulgence interpretations psychological warfare doctrine. Many times small armies with greater technological equipment and/or military tactical or strategic skills won: There are many examples, but two are Battle of Blood River (guns), conquest of North and South America ([guns, germs & steel](#)).

WiP Resource Conflict: Initially economic, then political, and finally military organized conflict: Centuries of conflict over resources generated an international law social contract founded upon Masonic phallic force (rule of force international treaties); that rewarded those who engage in [seething energies of lucifer](#) breeding and consumption wars; which bribe their tribes members to believe it is their 'inalienable [freedumb slavery] right' to breed and consume above carrying capacity limits; while denying personal responsibility for the human factory farming organized violence conquer and culling racism, sexism, nationalism, socialism, capitalism, nazism, islamism, zionism, corporatism, stalinism, [human sacrifice culling](#), etc consequences; as people are motivated beyond retardation (motarded) to choose to join one or other ideological, religious, racial or cultural tribe to engage in resource war thieving to accumulate more resources to grow their tribe to enable it to protect itself from another tribes organized violence resource war thieving.

All civilized religions — from Christianity, to Gnosticism, etc — were ‘created’ in the minds of man to comprehend the concept of ‘evil’ (aka organized violence), subsequent to man’s invention of agriculture, approximately 10,000 years ago; and where such agriculture created food surpluses, resulting in population surpluses, and expansion of their territory resulting in population pressure clashes with other tribes territories, resource war conflict.

If the tribe introduces agriculture, which results in an agricultural surplus and uses such agricultural surplus to justify greater population; then as the population increases, so the population pressures increase. There is less space to run away from someone who may be temporarily angry, or wanting something another is not willing to provide in that moment. The existence of ‘evil’ (organized violence) is plausibly directly proportional to the resource war conflict, resulting from the tribe’s violation of carrying capacity limits; and/or coming into contact with another tribe’s territorial expansion as a result of their violation of carrying capacity limits. In attempting to understand the existential meaning of this symptom of ‘evil’ resulting from violation of carrying capacity limits resource war conflict, man created religions...

The invention of agriculture and agricultural surpluses, and subsequent organized violence of civilization are the biblical story of Adam and Eve’s loss of living in carrying capacity harmony with the natural world resource abundant paradise, and Cain’s choice to be a farmer. Others saw opportunities for socio-political status benefits from exploiting the reality of organized violence (evil), and suppressed this conscious reality of their intentions by invoking various phallic ‘right’ justifications for their ‘right’ to engage in organized violence (evil).

Re: plausible deniable applicants and observers:

According to my observation two of the applicants could be considered plausible deniable committed to the implementation of an Ecology of Peace international law social contract. They are Timothy McVeigh and Vladimir Putin.

I imagine Timothy McVeigh shall remain plausible deniable until Pres Bush and/or Governor Gray Davis legally confirms his 11 June 2001 faked execution. Those negotiations can be found in: *Ecology of Peace culture correspondence regarding the Oklahoma City Bombing and the faked execution of Timothy James McVeigh [PDF]*. Succinct Summary of Private Prosecution Complaint:

On behalf of the EoP Applicants I have been preparing documentation for an ICC private prosecution in terms of Rendulic Rule Military Necessity doctrine; CA, UK, US & RSA Common Law Private Prosecution doctrine; Rome Statute: Art.5, 6, 7, 8 & 15; ICC Code of Judicial Ethics: Art 4, 5(1), 7 & 11. Charges: Crimes of Aggression Acts of War.

The Ecology of Peace culture's definition of 'crimes of aggression acts of war' is as follows: "Any individual who is found guilty of advocating on behalf of, legislating, enforcing, or obeying any – cultural, religious, common, statutory, constitutional, or international –

‘scarcity combatant’ social contract; which enables or advocates on behalf of human procreation, consumption or production of resources that transgress ecological carrying capacity limits, is guilty of the ‘crime of aggression act of war’.”

Carrying Capacity Sustainability: I=PAT Equation:

For activities to be genuinely sustainable it must be possible for them to continue indefinitely. The impact of humanity on the environment and the demands that people place on the resources available on the planet can be summarized by what is known as the Ehrlich or IPAT equation, $I=PAT$. I = impact on the environment or demand for resources, P = population size, A = affluence and T = technology. The two most important conclusions deriving from this IPAT footprint relationship are that: (i) the Earth can support only a limited number of people, at a certain level of affluence, in a sustainable manner; and (ii) Population and Consumption must be reduced to below carrying capacity.

An individual's IPAT footprint is a result of: (A) Consumption Footprint multiplied by (B) Procreation Factor.

Consumption Footprint: Consumption footprint calculators are based upon [Global Footprint Application Standards](#), and calculate an individual's consumption footprint based upon various questions about their consumption lifestyle's; and provide a final consumption footprint in global hectares which is the individual's ‘consumption footprint’; i.e. the amount of global productive land required for the production of products the individual consumes. Consumption Footprint calculators can be found at among others: [Global Footprint Network](#); [Earth Day](#); [Center for Sustainable Economy](#); [EcoCampus](#).

Global Footprint concepts were developed by among others: Dr. Mathis Wackernagel; Dr. William Rees; Dr. Herman Daly and the Global Footprint Network Standards Committee is one of two committees overseeing scientific review procedures and standards for Footprint calculations.

Procreation Factor: According to the research of [Paul Murtaugh](#): A parent increases their consumption footprint by a factor of 20 for every child procreated.

Carrying Capacity aka Biocapacity Limits: “The maximum number of individuals that can be supported sustainably by a given environment is known as its ‘carrying capacity’. Worldwide the total amount of biologically productive land and sea amounts to 12 billion global hectares (gha); or 1.8 gha each if divided by 6.7 billion each. Guerry's Laws are drawn up in accordance with the proactive conservation policies of Bhutan, who set aside 40% of their biologically productive to be returned to its natural state, for other species and wildlife conservation purposes; then that means that the total amount of biologically productive carrying capacity land available to humans is 60% of 12 billion; which amounts to 7.2 billion gha total; or 60% of 1.8 gha, which is 1 gha each.

Population factor is relevant, because the more humans there are, the less biologically productive land there is for everyone else.

Biocapacity limits of 6.7, 3.5, 1 Billion, 500, 250 & 100 Million humans: 7.2 billion global hectares of biologically productive land and water divided by (a) 6.7 billion humans,

equals: 1.07 gha each; (b) 3.5 billion equals 2.05 gha each; (c) 1 billion equals 7.2 gha each; (d) 500 million equals 14.4 gha each; (e) 250 million equals 28.8 gha; (f) 100 million equals 72 gha each.

The only people who appear to give a fuck about my sincerity and take me remotely seriously are Timothy and Vladimir: To avoid wild speculation as to what my response would be to Timothy's aforementioned plausible deniable ambiguous suggestion; I share this 'Lara response' to provide Timothy and related individuals with my answer; to avoid wasting Timothy, Vladimir, or my or any EoP Applicant -- concerned about these [Ecology of Peace v Masonic War is Peace](#) culture war issues -- time.
